Delivery charges will apply to Industrial Packaged Gases, Medical Packaged Gases, Special Gases, Refrigerants, Non-Regulated LPG Packaged and Hardgoods (Welding Equipment and Consumables). Delivery charges are subject to change.

No customer purchase orders will be processed from the effective date if no delivery charge is specified on your order. Afrox urges you to align your purchase order process by catering for the delivery charge to minimize any disruption in supply.

ANNEXURE A

DELIVERY CHARGE AND ESCALATION METHODOLOGY

Afrox will, from 1st July 2022, implement the delivery charges to its Packaged Gases and Products (“PGP”), Special Gases and Refrigerants, Non-Regulated Packaged, LPG, Hospitality and Hardgoods (Welding Equipment and Consumables) customer bases.

The delivery charge takes into consideration a number of elements and factors, including:

1. Fuel/diesel: Diesel 0.05% Sulphur,
2. Labour, and
3. Other transport components and requirements.

The Fuel Component: Diesel 0.05% Sulphur will be adjusted as a portion of the cost directly related to the published price (DMRE) by the first Wednesday of each month. Accordingly, the price may vary as the Fuel Component fluctuates.

For the Labour component, the price will be adjusted by Afrox effective March every year.

For other transport components, the price will be reviewed by Afrox quarterly.

Prices will be reviewed in accordance with the components, and weightings may vary from time to time based on input cost changes and other factors.
